

# Super Groundhog Saturdays

## Jet Stream Casino

### Official Rules

1. Jet Stream Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Jet Stream Casino is giving away up to \$5,000 in cash and prizes during the “Super Groundhog Saturdays” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Jet Stream; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning Tuesday, January 1, 2019 through Saturday, February 2, 2019 patrons will receive one (1) entry for every \$50 (and above) electronic gaming machine cash out ticket.
  - a.) Patrons must present their cash-out ticket to the Cashier’s Cage to receive their entries.
  - b.) Entries must be filled out legibly, using a pen, and turned into the designated hopper on the date they are received or they will be deemed invalid.
  - c.) Limit of ten (10) entries per patron per day during the length of the promotion.
4. On Saturday, January 19, 2019 beginning at 6:00pm to 9:00pm \$2,000 in cash will be given away as five (5) \$50, five (5) \$100, and five (5) \$250. On Saturday, February 2, 2019 beginning at 6:00pm to 9:00pm up to \$3,000 in cash and prizes will be given away as ten (10) \$100, **four (4) recliners valued at \$499 each.**
  - a.) Patron(s) must be present to win. Winner(s) will be announced and have two (2) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
  - b.) Each winner will select a mystery envelope and be awarded the corresponding prize listed inside.
  - c.) Limit of one (1) prize per Patron per drawing date during this promotion.
  - d.) Jet Stream Casino’s manual drawing system will be the sole determinant of each winner.
5. No Cash Option will be available during this promotion.
6. If for any reason a winner refuses their prize, a new winner will be drawn.
7. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
8. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
9. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
10. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.

11. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
