

Mega Frenzy Bingo Second Chance Jet Stream Casino

Official Rules

1. Jet Stream Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Jet Stream Casino is giving away \$1,820 in Mega Frenzy Bingo Tickets during our Mega Frenzy Bingo Second Chance” giveaway.
2. Patrons must be 18 years of age or older with a valid photo ID to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Jet Stream Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning 8:00a.m. Thursday, October 5, 2017, to 10:00a.m Friday, September 28, 2018, Patrons may turn their non-winning Mega Frenzy Bingo Tickets into the hopper located at the Cashier’s Cage for a chance to win \$35 in Mega Frenzy Bingo Tickets.
4. At approximately 10:00a.m. every Friday from October 6, 2017 to September 28, 2018 one (1) non-winning Mega Frenzy Bingo ticket will be drawn and the winner will receive \$35 in Mega Frenzy Bingo Tickets, for a total of \$35 each week.
 - a.) Patrons do not have to be present to win. If the winner is not present at the time of the drawing they will be contacted by Jet Stream Casino and given one (1) week to claim the prize. If the prize is not claimed within the designated time period it will be forfeited.
 - b.) One (1) Bingo Ticket consists of one Mega Frenzy Bingo Print out ticket regardless of number of games on said ticket.
 - c.) Patron’s name and a valid phone number must be provided on the back of the Mega Frenzy Bingo Ticket to be considered a valid entry. If any information listed above is missing or is illegible, the ticket will be considered invalid and a re-draw will be performed.
 - d.) All entry tickets will be removed from the hopper following the drawings each Friday.
 - e.) Jet Stream Casino’s manual drawing system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change,

cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
